ARTICLES OF THE COMPETITION

ARTICLE 1

- 1.1 On the occasion of the AGRISHOW, SILVA REGINA and BIOMASA international fairs held between 12 and 15 April 2026, the best exhibit competitions – GOLD MEDAL AGRISHOW 2026, GOLD MEDAL SILVA REGINA 2026 and GOLD MEDAL BIOMASA 2026 will take place.

ARTICLE 2

- 2.1 The Competition is intended for exhibits on display at the aforementioned international fairs with parameters comparable with world top class products or setting development trends in their disciplines.
- 2.2 The Competition may also be entered by exhibits winning awards at other exhibitions or in other competitions; however, the GOLD MEDAL AGRISHOW, GOLD MEDAL SILVA REGINA and GOLD MEDAL BIOMASA awards may be received by the same exhibit only once.

ARTICLE 3

- 3.1 The exhibit is understood as a product, or a service presented in an exhibition stand in a space rented by the fair organiser (exhibitor) or in an exhibition stand of the exhibitor (co-exhibitor, another represented company).
- 3.2 The exhibits may be entered into the competition by the exhibitor, co-exhibitor, manufacturer or an authorised legal or natural entity, such as an advertising agency, association, union etc. (hereinafter referred to as the "Entrant").
- 3.3 One Competition Entry Form may only be used for entering one exhibit while the number of the Entrant's registration forms is not limited save for sets of products that form a part of a single consumer package or a series or system forming a single user unit.

ARTICLE 4

- 4.1 The exhibits will be evaluated by an Evaluation Committee of experts in the respective fields. The Evaluation Committee's work is managed by its chairperson. The GOLD MEDAL award will be presented by the CEO of BVV Trade Fairs Brno based on the recommendation given by the Evaluation Committee.
- 4.2 The exhibits will be evaluated in categories determined by the Evaluation Committee according to the nature of the entered exhibits as part of the classifications within the individual fairs. Each exhibit may only be evaluated in one category. The classification in the competition category is made by the Evaluation Committee.
- 4.3 The special category SOIL WATER RETENTION FRIENDLY is intended for exhibits that have a positive effect on soil properties leading to improved soil retention. SMART FARMING is intended for exhibits that use modern technology to increase

the quality and quantity of agricultural production. Exhibits should have a high proportion of automation and robotics, make use of independent information and communication technologies or create elements of cooperative systems. Entries for these categories can be made directly on the entry form where the boxes for these categories are marked.

- 4.4 The Evaluation Committee will evaluate the exhibits according to criteria listed under Article 6.1 in two basic rounds:
1st round – pre-selection from the evaluated exhibits,
2nd round – evaluation – final selection.
- 4.5 The first round of evaluation will take place before the fair opening based on supporting data provided by the Entrant. During the evaluation of the second round, the applicant is obliged to provide the Evaluation Committee with a qualified demonstration of the exhibit at the stand in the period of one day before the opening of the fair, i.e. on **11 April 2026 between 1.00 and 5.00 pm.**
- 4.6 During the evaluation, the Evaluation Committee has a right to request of the Entrants or, as the case may be, the Exhibitors, any additional information about the exhibit and make use of information from other sources for the evaluation. The Evaluation Committee itself determines the importance of the relevant available item of information. During the evaluation, the Evaluation Committee will put more emphasis on verified data.

ARTICLE 5

- 5.1 Basic terms and conditions for entering the competition:
- 5.1.1 Submission of a duly filled-in competition entry form **in electronic form only** within deadline, i.e. **by 30 March 2026** – after this date, the Entrant is not entitled to enter the competition.
- 5.1.2 Delivery of documentation characterizing the exhibit in detail. All documentation must be delivered in electronic form!
- 5.1.2.1 Compulsory supporting data:
– a brief description of the exhibit (approx. 5 sentences), technical parameters, operating instructions,
– specification of advantages compared to the competition (approx. 5 sentences),
– illustration of the exhibit (JPG format),
– presentation of the exhibit in terms of its use and practical application,
– certificates and documents proving compliance with the legislation required for placing the product on the market,
– description of compliance with the evaluation criteria listed in Articles 6.1.1 to 6.1.7.
- 5.1.2.2 Supporting documents – data and documents concerning the arguments provided in the compulsory supporting data (e.g. official documents, approvals, permits, testing protocols from internal or independent test rooms, certificates, declarations of conformity, contracts, designs, drawings, calculations etc.)
– promotional and information material concerning the exhibit,
– description and picture of the exhibit in operation (video sent via web storage),
– specialist articles and publications,
– user references,
– information about any prizes already awarded to the exhibit,
– further information at the Entrant's discretion.

- 5.1.3 Payment of the registration fee to the account held by the organiser, totalling:
– for one entry CZK 4,000 + VAT
– for each next entry CZK 3,000 + VAT.
Once the registration fee is paid based on a duly filled in entry form, all Entrants will receive an invoice in the relevant accounting period.
- 5.2 For the purpose of promoting and presenting the evaluated exhibits (posting on the Internet, press releases etc.), the promoter requires the following:
– short annotation (in Czech and English) in a max. scope of 5 sentences characterising the competition exhibit,
– colour photograph of the exhibit in adequate quality (ideally a product photo best characterising the competition exhibit).
- 5.3 The duly filled in entry form, supporting data for the evaluation, registration fee payment receipt, annotation and photograph of the exhibit must be delivered **by the deadline, i.e. 30 March 2026** to Jaroslav Bílek (tel.: +420 541 152 966, +420 602 584 376, e-mail: jbilek@bvvcz).
- 5.4 The entry form, text and visual information and/or multi-media files must be sent **solely in electronic form** (by e-mail or via web storage – as separate documents marked as: entry form, compulsory data, supporting data, annotation, photo, etc.).
- 5.5 Once the exhibit meets the basic conditions for being entered into the competition, it will be put on the official list of evaluated exhibits which will be continuously posted on the internet including annotations and along with other current information.

ARTICLE 6

- 6.1 Basic evaluation criteria:
- 6.1.1 novelty of the product, innovation, originality of the conceptual, structural and functional design with a documented effect, technical and technological standards, user comfort (provision of guarantee and post-guarantee service, safety of operation, occupational hygiene, technical compatibility and application in the lines and systems in the Czech Republic, operation efficiency, etc.),
- 6.1.2 readiness of the exhibit for deliveries onto the Czech market (in terms of production, sales and compliance with legislative requirements),
- 6.1.3 craftsmanship of the whole and the details, design,
- 6.1.4 ecological aspects,
- 6.1.5 overall presentation level of the exhibit.

ARTICLE 7

- 7.1 The entered exhibit will not be evaluated if: the Entrant fails to meet the basic conditions for being included in the Competition (Art. 6.1),
- 7.1.1 the Entrant or as, the case may be, the exhibitor, fails to provide additional qualified information about the exhibit necessary for proper evaluation at the request of the Evaluation Committee or the Promoter,
- 7.1.2 the Entrant cancels its participation at the fair,
- 7.1.3 the Entrant removes the exhibit from the competition,
- 7.1.4 the exhibit will not be on display at the fair, If not evaluated for reasons specified under Article 7.1, the Entrant is not entitled to the registration fee refund.

ARTICLE 8

- 8.1 The evaluated exhibits, the results of the competition (nomination and evaluation) and the list of the Evaluation Committee's members will be continuously made public via press releases and on the website of the competition promoter and expo organiser.
- 8.2 The official announcement of the competition results will take place at the gala evening of the AGRISHOW, SILVA REGINA and BIOMASA fairs on **Sunday 12 April 2026 at 7 pm.**
- 8.3 The winning exhibits will receive an original prize and a diploma that can be used to further promote the winning exhibit. For these purposes, the award-winning company is also entitled to use the competition logotype.
- 8.4 The evaluation process is not public, and no appeal can be made against the final decision. The competition promoter and expo organiser is not obliged to provide rationale for the decisions of the committee.
- 8.5 The promoter guarantees that the award-winning exhibits will be presented through media partners. At the same time, it undertakes to provide information about the competition and its results to additional media.

ARTICLE 9

- 9.1 The promoter reserves the right to respond to technical and organisational circumstances that may result in changes in the deadlines or the course of the competition. All Entrants are guaranteed timely information.
