






Octanorm sales counter- option A: 1 x 1 m

General information

- 1. Special pricing conditions are valid only for registrations by 30/09/2025 and payment of the P/I invoice by 10/10/2025 at the latest.
- 2. From 01/10/2025, the standard rates for different types of participation apply, the P/I invoice is to be paid by 10/10/2025. The registration after 10/10/2025, payment immediately. In the case of unpaid invoice the exhibitor will not be guaranteed exhibition space.
- 3. CANCELLATION FEE: in case of cancelled participation after 07/11/2025, the trade fair management will claim a cancellation fee of 100% from the exhibitor.
- 4. Exhibitors must not use any space for presenting their products other than the rented one, ie. they must not extend their exhibition stand by any equipment and reach beyond their ordered and allocated space.
- 5. Placement of exhibitors in the Hall is at the full discretion of the organizer Fair Administration.
- 6. The listed prices include 21 % VAT
- 7. The exhibition space must be marked with the name of the exhibitor or company.
- 8. All the exhibits or groups of exhibits on display must be marked with a label showing the name of the mineral, locality and price. Synthetic and additionally coloured stones and products made of them must also be duly marked.
- 9. During the exhibition, the showcased range of products will be continuously checked by the organisers and authorised personnel according to the defined exhibition Product Categories. If the presented exhibits do not match the specified commodity nomenclature (objectionable or inappropriate exhibit in the form of a fake), the exhibitor will be immediately asked to remove such goods from the exhibition space. Repeated breach of this rule will result in the withdrawal of the allocated exhibition space by the organiser without any financial compensation.
- 10. In particularly serious cases, the exhibitor may be permanently banned from attending all exhibitions and fairs organised by BVV Trade Fairs Brno.
- 11. If the exhibits listed in the exhibitor's registration fail to comply with the defined Product Categories, the trade fair administration is entitled not to register them.

- 13. The exhibitors must be insured, they are liable for any damage that may occur!
- 14. How to get to the venue: From the main train station take tram No. 1 get off at "Výstaviště hlavní vstup"; from the main coach station take bus No. 84 direction BVV, get off at "Křížkovského"; by car go to Gate 4 of BVV fairgrounds.
